This includes the food facilities within the Student Union Building consisting of Lighthouse Café, serving sandwiches, salads, grilled products, and beverages; Freudian Sip coffee house, serving a traditional coffee house menu of regular and specialty coffee beverages, smoothies, pastries, and frozen yogurt; the Sea Store which is a small convenience store; Pizza 3.14, serving pizza, wings and salad; and the Town Center Market, offering a Freudian Sip coffee house, a deli and a market. A second Freudian Sip coffee house is located in the Broome Library. Located adjacent to the South Quad, Islands Café, provides dining for the campus' residential students and catering to the general campus.
