University Glen Corporation is responsible for all food operations on the California State University, Channel Islands campus. This includes the food facilities within the Student Union Building consisting of Lighthouse Café, serving sandwiches, salads, hot dogs, grilled products, and beverages; Freudian Sip coffee house, serving a traditional coffee house menu of regular and specialty coffee beverages, smoothies, pastries, and frozen yogurt; and the Sea Store which is a small convenience store. A second Freudian Sip coffee house is located in the Broome Library. Located adjacent to the South Quad, Islands Café, provides dining for the campus' residential students and catering to the general campus.

University Glen Corporation operates as an Auxiliary Organization for California State University Channel Islands for the purpose of providing affordable housing for staff, faculty and educational allies; which includes the management of 474 residential rental units, 14 retail spaces, and the management of 184 for sale residential units.
